5. TOXICOLOGICAL INFORMATION

Cosmetics Directive 7th Amendment: Restrictions may apply. A source of Limonene and Linalool, listed as a sensitiser. Check maximum usage levels for skin care products.

IFRA recommend that for applications on areas of skin exposed to sunshine, excluding bath preparations, soaps and other products which are washed off the skin, the total level of bergapten (5-methoxypsoralen) in the consumer products should not exceed 0.0015% (15ppm). This is equivalent to 0.0075% (75ppm) in a fragrance compound used at 20% in the consumer product. The typical level of bergapten in Tangerine Oil, Cold Pressed is 50ppm.

6. STABILITY & REACTIVITY

Reactivity: It presents no significant reactivity hazards, by itself or in contact with water. Avoid contact with strong acids, alkali or oxidising agents.

Decomposition: Liable to cause smoke & acrid fumes during combustion: carbon monoxide, carbon dioxide & other non-identified organic compounds may be formed.

7. HANDLING & STORAGE

Precautions in Handling: Apply good manufacturing practice & industrial hygiene practices, ensuring proper ventilation. Observe good personal hygiene, and do not eat, drink or smoke whilst handling.

Storage Conditions: Store in tightly closed original container, in a cool, dry & ventilated area away from heat sources & protected from light. Keep air contact to minimum.

Fire Protection: Keep away from ignition sources & naked flames. Take precautions to avoid static discharges in working area.

Disposal Considerations: Avoid disposing to drainage systems and into the environment. Seek expert advice.

Shelf Life: When stored within advised conditions, re-test after 12 months then at 3 monthly intervals up to a maximum shelf life of 36 months.

8. FIRST-AID MEASURES

Inhalation: Remove from exposure site to fresh air. Keep at rest. Obtain medical attention.

Eye Contact: Rinse immediately with plenty of water for at least 15 mins. Contact a doctor if symptoms persist.

Skin Contact: Remove contaminated clothes. Wash thoroughly with soap & water, flush with plenty of water. If irritation persists, seek medical advice.

Ingestion: Rinse mouth out with water. Seek medical advice *immediately*.

9. FIRE FIGHTING MEASURES

Extinguishing Media: Use CO₂, Dry Powder or Foam type extinguishers, spraying extinguishing media to base of flames. Do not use direct water jet on burning material.

Extinguishing Procedures: Closed containers may build up pressure when exposed to heat and should be cooled with water spray.

10. ACCIDENTAL RELEASE MEASURES

Personal Precautions: Avoid inhalation & direct contact with skin & eyes. Use individual protective equipment (safety glasses, waterproof-boots, suitable protective clothing) in case of major spillages.

Environment Precautions: Keep away from drains, soils, surface & groundwaters.

Cleaning Up Methods: Remove all potential ignition sources. Contain spilled material. Cover spillages with an inert or non-combustible inorganic absorbent material, sweep up and remove to an approved disposal container. Observe state, federal & local disposal regulations.
